IN SEPTEMBER, 2013, CANCER CAREPOINT MOVED INTO A LARGER SUITE ON THE SAMARITAN MEDICAL CENTER CAMPUS -- FROM 600 SQ. FT. TO 2,100 SQ. FT. SERVICES CONTINUED BUT ON A LARGER SCALE. SERVICES INCLUDED NUTRITION, MASSAGE, COUNSELING, GUIDED IMAGERY, COMMUNITY EDUCATION, SEVERAL SUPPORT GROUPS, YOGA CLASSES AND MOVEMENT CLASSES. SERVICES CONTINUED TO BE OFFERED FREE OF CHARGE.
